In closing I would like to thank Steve and his crews for all the work they did that hot, humid, Sunday afternoon here in Park City. It was a pleasure to meet, and get to know Steve and all your guys who worked so hard on our behalf. We are unable to provide you with the names of all your crew members. If you are able to identify them, we would be most grateful if you would please convey our thanks, and share this letter with them. Would you also please provide Mr. Steve Huff with a copy of this letter? Please know that all your employees, who worked here in Park City, are a credit and valuable asset to your corporation. Your board should be very proud of each and every one of them. I know that here in Park City, we are, and we will never forget them. Thanks for sending Florida "the best of the best."
